#### - Community Committee Report (Burr Tupper)

- Newsletter

- The Spring 2024 Newsletter went out to members, and I got several very positive comments on the content. One of the respondents, 90-year-old Ned Youst, thought that we ought to contact

an old college roommate based on the priority waters article. His old roommate has a farm south of Front Royal and there is a spring fed creek that runs through it and then runs into the Shenandoah River. The landowner is interested in having TU get involved in evaluating for a home waters project as there are brook trout in it.

- Burr will be trying to recruit members to help with the newsletter. We will need to get material from each of the chapters, edit and then publish. Hope to publish another newsletter in September.

- Burr is looking at adding sections: Introduction of council staff, Feature chapter, and Tackle box Highlight or Tips

### - Grant Programs

- The Shenandoah Chapter has used the grant money that the Council provided them to purchase Data Loggers for their Buffalo Creek project and help with the landowner's recognition dinner.

- Will Ramsey has requested an educational grant for a TU college program in northern Wyoming. His request was forwarded to Stan Ikonen for evaluation and recommendations to the Council. Stan has agreed to be the education grant coordinator and all requests should be sent to him.

- Note: Wills grant for \$500 was reviewed and approved (Scott)

- Funding

- Fund raising for the Council's projects and programs that support the TU mission will need to be addressed in the future. The Council efforts should not conflict with the individual chapter effort.

- The Council should ask members for ideas that can be discussed in future meetings.

### - TIC Report (Mike Makufka)

- Year to Date Progress:

- Most schools are in the process of either releasing their trout or will be releasing them soon. There are eleven schools that have asked to join the program for next year. I will be asking the chapter coordinators for their feedback so that I can prepare the final report for DWR. Overall, it was a very good year.

- TIC Manual:

- I am writing the first draft of the updated TIC state manual. I should have that completed by month's end and then I will be sending it out to be proofread. The manual should be completed by next school year's TIC programs.

#### - DWR Photos and Videos:

- Meghan Marchetti, who is the Creative Content Producer at the Virginia Department of Wildlife Resources, emailed me to request videos or photos that show TIC activities with students. I did send several to her. I have not heard anything more about the status of the project.

- TC Energy Grant Request:

- I had several talks with Rebecca McIlroy who coordinates the grant program for TC Energy. We talked about the needs for the TIC program, and I will be submitting a grant request by the end of May. I do not yet know the dollar amounts, but I am requesting funding for helping chapters

with initial costs and equipment replacement, including chemical reagents. A second component to the grant will be for offsetting bus transportation costs for the field trips to release the trout. I am thinking about a split of 33% grant, 33% chapter and 33% schools but those percentages could change depending on chapter needs.

- I will send the grant proposal to both Jim Wilson and Bill Pierce and anyone else that needs to read it for approval before submitting.

- Please send me any comments about the grant the Executive Committee may have.

- The question I have is whether the grant application needs a 1099 letter and 501c3 verification. Does the state council have these, or do we use National TU's numbers? I will check with TU to get their thoughts.

- It was noted that the cover letter that Mike put together takes care of getting individual special permits to release fish in national park waters (John)
